TERM OF REFERENCE FOR CONTRACTUAL APPOINTMENT FOR ALL POSTS

1. The appointment is purely on Contract basis for a period of one year or till the regular incumbent joins, whichever is earlier. The appointment can be terminated at any time (on either side) by giving one month's Notice or by paying one months salary without assigning any reason or failure to complete the period of three months to the satisfaction of the Competent authority.
2. The appointee shall perform the duties assigned to him. The competent authority reserves the right to assign any duty as and when required. No. extra/additional allowance will be admissible in case of such assignment.
3. The appointee shall not be entitled to any benefit like provident Fund, Pension, gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government Servant appointed on regular basis.
4. No accommodation will be provided.
5. The appointee will not be granted any claim or right for regular appointment to any post in Food research and Standardization Laboratory, Ghaziabad.
6. Only consolidated salary will be admissible. No Dearness Allowance and other allowances as are admissible to the Central Government Servant shall be admissible.
7. The appointee shall be on the whole time appointment of the Food Research and Standardization Laboratory till the duration of Contract and shall not accept any other appointment, paid or otherwise and shall not engage himself/herself in private practice of any kind during the period of Contract.
