SUB: Cadre Allocation of CMSE – 2009 candidates – reg.

The undersigned is directed to say that the Union Public Service Commission have recommended and forwarded dossiers of 450 candidates (including 74 belonging to Scheduled Caste(including 1PH), 36 belonging to Scheduled Tribe, 130 belonging to Other Backward Classes (including 04 PH) and 210 General candidates (including 11 Physically Handicapped) who have been declared successful on the basis of the final result of the Combined Medical Services Examination - 2009 to the following services/posts:-

1. Assistant Divisional Medical Officer in the Railways.
 2. Junior Scale Posts in Indian Ordnance Factories Health Service.
 3. Junior Scale Posts of Medical Officers in Central Health Service.
 4. Medical Officers in the Municipal Corporation of Delhi.
 5. G.D.M.O. in New Delhi Municipal Corporation (NDMC).
2. The total number of vacancies as intimated by the concerned Ministries, and MCD is 512 including 74 for Scheduled Castes, 36 for Scheduled Tribes, 130 for OBC Category and 16 Physically Handicapped. A photocopy of the vacancy statement is enclosed for reference at Annexure-III. The 59 OBC and 3 SC candidates whose names are given in Annexure-IV have come up in the General merit and are to be considered at par with the general candidates in the matter of allocation of services subject to the provisions of Rule 13 of CMSE-2009 rules. The recommendations of the Commission have been received vide their letter No.F.1/5/2009-E.XIII dated 12.05.2010 (copy enclosed) and may be seen for necessary action and compliance.
3. The UPSC have also indicated the roll numbers of some candidates (as indicated in Annexure-I, and Annexure-II to their letter) who are required to submit some original documents. The candidates whose roll numbers are given in Annexure-I have to submit certain documents in original or yet to satisfy certain other requirements of the rules as indicated against their Roll Nos. The documents shown against these conditional candidatures need not be sent to the Commission and the same as and when received from the candidates may be verified by the respective Ministry/Department to which the candidate is allocated. However, on this account their appointment, if they are otherwise eligible, need not be withheld. Annexure-II indicates the roll numbers of candidates whose candidature is still provisional and who have to submit some original documents including SSLC/Caste Certificate in certain cases. It may be noted that the offer of appointment should not be made to candidates whose roll numbers are given in Annexure-II and whose candidature is provisional, unless the documents required in their cases have been obtained and sent to the commission for verification and clearance obtained. A copy each of the Annexures is also enclosed. The concerned cadre authorities are requested to correspond with UPSC directly in the matter of verification of documents of candidates as mentioned in Annexure-II.

4. Keeping in view the number of vacancies intimated, rank obtained by the candidates, preference given by the candidates etc. the candidates recommended by the Commission have been allocated under:-

- 5. Complete Medical Examination (Part-I & Part II X-ray Chest) of the successful candidates of CMSE-2009 was done at the time of interviews by Ministry of Health & FW.
- 6. The formality regarding the verification of character and antecedents of each of these candidates may also please be completed by the concerned cadre controlling authority on the basis of the attestation form (placed in the dossiers) as and where received and to be called for from the candidates wherever same have not been received. Status about receipt of Attestation Forms from the candidates concerned has been indicated in column 6 of Annexure-IV.

7. The candidates may be appointed after completion of formalities of their medical examination and the verification of their character and antecedents and also after obtaining clearance from the UPSC in respect of the candidates whose candidature is provisional as per details given in Annexure-II. In some cases clearances from UPSC have also been received and the same have been added to the concerned dossier. Position in this regard has been indicated in Annexure-IV.

8. The copies of the SC/ST/OBC certificates submitted by the candidates claiming to be belonging to these communities have been added to their respective dossiers. The claim of these candidates to belong to SC/ST/OBC has been accepted by the UPSC on the basis of the original certificates produced by them. As the cases have occurred where candidates had obtained SC/ST/OBC certificates even though they did not actually belong to those communities. It is, therefore, requested that necessary action may be taken to verify the veracity of these documents positively before making offer of appointment to the candidate concerned. Also, there may be some cases where though OBC certificates have been issued to the candidates, the "creamy layer" status may be doubtful keeping in view the income/status of the parents of the candidates as per declaration of the candidates in column 16 of the Detailed Application Form. These candidates have been provisionally treated as OBC candidates subject to the Govt. satisfying themselves about genuineness of their OBC claim. Before appointing such candidates, it may be ensured that they do not attract "Creamy Layer" provisions.

9. Since the appointment of the concerned candidate is subject to the candidates satisfying the appointing authority of his/her having satisfactorily completed the Compulsory Rotating Internship, the Cadre Controlling Authority should ensure and satisfy themselves before the candidates are appointed only after completing the Compulsory Rotating Internship satisfactorily. A copy of the offer of appointment as and when issued to the concerned candidates, after completion of all formalities as indicated above, may please be endorsed to the Union Public Service Commission who may also be informed as soon as the candidates join duty. The copy of offer of appointment is not required to be sent to this Ministry. In addition to this the Assessment Reports on the work and performance of candidates appointed should be made available to UPSC every year for a period of five years subsequent to their appointment. The concerned candidates may also be informed of their being allocated to the respective cadres.

10. The allocation of Physically Handicapped candidates have been done on the basis of functional classification and number of vacancies identified by the different cadre authorities and intimated to Union Public Service Commission.
