# Causality assessment report of 367 reported Serious Adverse Events Following Immunization (AEFI) cases, approved by National AEFI Committee

The Immunization Division of Ministry of Health & Family Welfare has taken several steps to improve the National AEFI surveillance system, both the quality of investigation of cases at state level and their causality assessment at national level. Considering the importance and critical nature of the task, SOPs for causality assessment (CA) have been laid down as quality assurance. The CA subcommittee is housed at Lady Harding Medical College which is also the National AEFI Technical Collaborating Centre. The first round of Causality Assessment is undertaken by this subcommittee.

AEFI deaths, attributed to the vaccine or programme error are reviewed again by a specially constituted review panel comprising of the chairs of the 4 subcommittees of the National AEFI Committee (i.e. Causality assessment, investigation, media and laboratory subcommittees) chaired by Chairman, National AEFI committee. The causality assessment reports are presented to the National AEFI Committee. The pool of national experts trained on WHO's globally accepted Causality Assessment Protocol has so far conducted 14 meetings between 2012 and Dec 2014. The National Committee meets thrice in a year.

The results of the Causality Assessment for 367 cases completed over the past few months after thorough review, deliberation and approval by the National AEFI Committee is placed below (The anonymized line list of the causality assessment done by the National AEFI Committee as annexure).

Most of the reported serious AEFIs are coincidental (104) and none have been found to be due to quality defect in manufacturing vaccines. It is important to note that during 2012-2014, approximately 1,346 million doses of all antigens were given in the country while only 1,759 cases of serious AEFIs were reported indicating that the AEFI events are well within the expected rates though there is an overall need to further improve surveillance.
