

- 1. Name of the post, Pay Band + Grade Pay & Eligibility conditions:-
 - (i) <u>Senior Deputy Director General (Administration)</u> (One post) in the pay band -4 Rs. 37400 67000 + Grade Pay Rs. 10,000/-
 - (ii) <u>Eligibility Conditions</u>: All India Service Officers holding the post at the level of Joint Secretary or suitable for such appointment.
 - (iii) <u>Desirable:</u> Experience in Health Sector and / or in Research Organizations.
- 2. Willing & eligible officers may submit their application along with detailed CV (giving the past assignments and the work handled by the officer) through proper channel only (i.e through cadre controlling authority) so as to reach the Assistant Director General (Administration), Indian Council of Medical Research 110029, V. Ramalingaswamy Bhawan, Ansari Nagar, Post Box 4911, New Delhi-110029 on or before 30.10.2012. Advance copy may be sent but only those applications will be considered for whom approval of cadre controlling is received.
