Sub: Declaration of Assets and Liabilities and filing of returns by public servants under Section 44 of the Lokpal and Lokayuktas Act, 2013 and rules framed thereunder- reg.

The undersigned is directed to refer to the Lokpal and Lokayuktas Act, 2013 and the rules framed thereunder and to say that all the public servants as defined in the Act, working in the organisations under administrative control of this Ministry, are required to make declaration of Assets and Liabilities and to file returns in the prescribed form on or before 31st July, 2016 as detailed hereunder:-

(i) The first return of assets and liabilities as on 1st August, 2014 under the Lokpal and Lokayuktas Act, 2013 – on or before the 31st July, 2016

(ii) The next annual return of assets and liabilities as on 31st March, 2015 under the Lokpal and Lokayuktas Act, 2013 – on or before the 31st July, 2016.

- (iii) The annual return of assets and liabilities as on 31st March, 2016 under the Lokpal and Lokayuktas Act, 2013 should be filed on or before 31st July, 2016.
- (iv) The annual return for subsequent years as on 31st March every year should be filed on or before 31st July of that year.
