CIRCULAR

It is proposed to fill up two vacant posts of Drugs Controller (India) in the Grade Pay Rs.8700+PB-4 (Rs.37400-67000), Directorate General of Health Services by Deputation (ISTC) from officers under the Central/State Governments/Recognized Research Institutions/ Public Sector Undertakings / Semi Government/ Autonomous Statutory organizations:

- a) (i) holding analogous posts on regular basis in the parent cadre/department; or
(ii) with five years' service in the grade rendered after appointment thereto on a regular basis in posts in pay band-3 in the scale of Rs.15600-39100 with Grade Pay Rs.7600/- or equivalent in the parent cadre/department; and

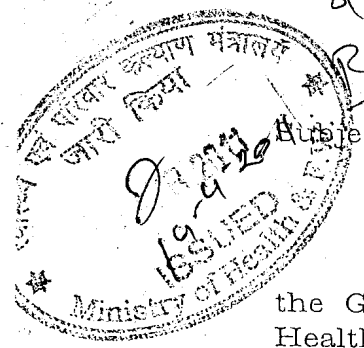
