I am directed to convey the sanction of the President for release of **Rs.1,29,79,600/-** (Rupees one crore twenty-nine lakh seventy-nine thousand and six hundred only) as grant-in-aid under the National Programme for Health Care of the Elderly (NPHCE), towards Central Share of Non-Recurring Grant (final installment) towards (i) construction/ renovation/ extension of the existing building and furniture of Geriatric Unit with 10 beds and OPD facilities & machinery and equipment at District Hospital, (ii) machinery and equipments at CHCs (iii) machinery & equipment at PHCs and (iv) aids and appliances at Sub-Centres in the following districts, as indicated against each:-

6. The grant-in-aid will be subject to the condition laid down in GFR 206 to 215 (3) of the General Financial Rules- 2005. Other terms and conditions shall be as per operational guide lines of the above said scheme.


