- G.S.R. In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Directorate General of Health Services Sr. Design Assistant Grade II Group 'B' Recruitment Rules, 1986 and Design Assistant Grade II Group 'C', 1985 respectively, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Assistant (Architectural Department) in the Department of Health and Family Welfare, Ministry of Health and Family Welfare namely.
- 1. Short title and commencement. (1) These rules may be called the Ministry of Health and Family Welfare, Department of Health and Family Welfare Assistant (Architectural Department) Recruitment Rules, 2016.
- (2) They shall be deemed to have come into force on the date of their publication in the Official Gazette.
- 2. Application. These rules shall apply to the posts specified in the Schedule annexed to these rules.
- Number of post, classification Pay Band and Grade Pay or scale of pay. The number of post, its classification, Pay Band and Grade Pay or scale of pay attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 4. Method of recruitment, age limit and qualifications, etc.- The method of recruitment, age limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (13) of the said Schedule.
- 5. Disqualification. No person,
 - a) who has entered into or contracted a marriage with a person having a spouse living, or
 - b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 6. Power to relax.- Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing, and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
- 7. Savings.- Nothing in these rules shall affect reservations, relaxation of ageilimit and other concessions required to be provided for Scheduled Castes, Scheduled Tribes, Other Backward Classes, ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
