It is proposed to fill up the post of Drugs Controller (India) in Grade Pay Rs.10000/- plus Pay Band-4 (Rs.37400-67000), Directorate General of Health Services by Deputation (ISTC) from officers under the Central/State Government/Union Territories/Recognized Research Institutions/ Public Sector Undertakings/ Semi-Government/ Autonomous/ Statutory organizations:

- A (i) holding analogous posts on regular basis in the parent cadre/department; or
  - (ii) with three years' service in the grade rendered after appointment thereto on a regular basis in posts in Pay band-4 (Rs.37400-67000) with Grade Pay Rs.8700/- or equivalent in the parent cadre/department; and

For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 01.01.2006 shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the Pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with common grade pay or pay scale where this benefit will extend only for the post(s) for which that grade pay or pay scale is the normal replacement grade without any upgradation.
