On promotion to the post of Supertime Administrative Grade, the pay of the officers shall be fixed in the scale of Pay Band-4(Rs.37400-67000) with Grade Pay Rs.10000 plus NPA at the prescribed rates, (pre-revised scale of pay of Rs.18,400-22,400 plus NPA at the prescribed rates) under FR 22(I)(a)(1). The officer has the option, to be exercised within one month from the date of communication of the order, to have the pay fixed under the rule from the date of promotion or to have the pay fixed initially at the stage of the time-scale of the new post above the pay in the lower grade or post from which he/she is promoted on regular basis, which may be refixed in accordance with FR 22(I)(a)(1) on the date of accrual of next increment in the scale of the pay of the lower grade or post.
