1. Walk in interview for the two posts of Specialist (Psychiatry) in the non-teaching sub-cadre of CHS on purely **contract basis** for a period of one year will be held on 26.06.2013 in Office of the Director, Lady Hardinge Medical College & Smt. S. K. Hospital, New Delhi

2 **Emoluments**

Selected candidates will be paid total emoluments of Rs.65, 000/- per month.

3. The educational qualifications and experience required for the post of Specialist (Psychiatry) is as under: -

**Essential Qualification:**

1. A recognized Medical Qualifications included in the first or Second schedule or part II of the III schedule (other than licentiate qualification) to the Indian Medical Council Act, 1956. Holders of educational qualifications included in part II of the third schedule should also fulfill the condition stipulated in sub section (3) of section (13) of the Indian Medical Council Act, 1956.

2. A recognized Post Graduate Degree/Diploma in the speciality mentioned in Section A or Section B in schedule VI or equivalent.

3. Three years' experience in the specialty after obtaining the Post-graduate degree or five years' experience in the speciality after obtaining the Post-graduate Diploma.

4. **Age Limit:**

Up to 45 years. Relaxable for Government Servants, Scheduled Castes, Scheduled Tribes and Other Backward Classes candidates. Upper age limit up to 5 years is relaxable for Scheduled Castes, Scheduled Tribes and 3 years in the case of OBC candidates.

5. **Other terms & Conditions**

1. The appointment of shall not confer any right or preference for regular appointment.

2. In case regular candidate joins, the appointment shall automatically stands terminated.

3. No claim for any service benefit like PF, Pension, Gratuity, Medical Allowance, Seniority & Promotion etc. from this contract appointment will be admissible.

4. No TA/DA will be admissible for interview or joining
5. Candidates on selection shall be allowed to join only when found medically fit.
6. Mere possession of minimum educational qualification will not automatically confer the right for appearing in the walk-in-for interview. If the number of application is very large, the competent authority reserves the right to shortlist candidates on the basis of higher qualification/years of experience in the subject.
7. The candidate who is already in Govt. Service should submit “No Objection Certificate” from the Employer at the time of Interview.
