ORDER

The President is pleased to promote 13 (Thirteen) Associate Professors belonging to Teaching Specialist sub-cadre of Central Health Service (PB-3 with GP Rs.7600/- in the Pay Scale of 15,600 – 39,100)) as mentioned in the annexure to this order to the grade of Professor (PB-4 with GP Rs.8700/- in the Pay scale of 37,400 – 67,000) plus N.P.A., as admissible under the rules, with effect from the dates mentioned against each.

2. In the event of an officer, who is being promoted as Professor and is on study leave/other kind of leave/deputation/foreign assignment etc., the promotion order will take place from the date he/she assumes charge on completion of his/her leave/deputation/foreign assignment.

3. In case any officer happens to be on unauthorized absence, he/she may not be promoted till a decision regarding his/her authorized absence is taken. The details of such cases may be reported to this Ministry. Further, in case of officers who were /are on training/fellowship etc. certified to be in public interest and are treated on duty during the said period of training/fellowship, their promotion will take effect from the dates mentioned against the name of each.

4. On promotion to the post of Professor, the pay of the officers shall be fixed as per the existing rules/instructions issued by the Government from time to time. The inter-seniority of the promoted officers will be maintained.
