The Ministry of Health & Family Welfare, Government of India has set up AIIMS at Bhopal, Bhubaneswar, Jodhpur, Patna, Raipur and Rishikesh under Pradhan Mantri Swasthya Suraksha Yojna as Institutes of National Importance. Application from eligible candidates are invited in the prescribed proforma for appointment on deputation basis to the post of Financial Advisor at each of AIIMS at Bhopal, Bhubaneswar, Jodhpur and Rishikesh. The last date for receipt of application is within 45 days from the date of publication of the advertisement in the Employment News.

Duly filled application along with attested copies of all relevant certificates are to be sent by the applicant to Shri Kailash Chand Samria, Joint Secretary (PMSSY). Room No. 346-A Wing, Nirman Bhawan, New Delhi 110108 superscribing on the envelope "Application for the Post of Financial Advisor AIIMS Bhopal, Bhubaneswar, Jodhpur and Rishikesh."
- **III. Period of Deputation**, including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not exceed three years.
- **IV. Upper age limit**: The maximum age limit for appointment by deputation shall be not exceeding 56 years on the closing date of receipt of applications.
- V. Eligibility: (i) Officers in the Group 'A' of Organized Accounts Services who are empanelled for appointment as Director in the Central Government Ministries/Departments or (ii) Officers in other Group 'A' Central Services who are empanelled for appointment as Director in the Central Government Ministries/Departments possesing any of the following qualifications, viz. Chartered Accountancy (CA) /Indian Cost & Works Accountancy (IC&WA)/Company Secretary (CS)/M.Com. from a recognized University.
- Failing (i) and (ii) above, Group 'A' Officers of Central Services holding the post of Deputy Secretary or equivalent on regular basis, in the pay band of Rs. 15600-39100 + GP of Rs. 7600/- and having any of the following Educational Qualifications, namely Chartered Accountancy (CA)/ Indian Cost & Works Accountancy (IC&WA)/ Company Secretary (CS) /M.Com. from recognized University may also be considered for the post. However, they will be allowed pay in their present grade with admissible Deputation (Duty) Allowance or get their pay fixed under the provisions of FR-35, till they become eligible for empanelment as Director. Officers serving in the "State Government's Finance Service" drawing a Grade Pay of Rs. 7600/- and above are also eligible to apply.
- VI. Pay Band 4: Rs.37400-67000 + with Grade Pay of Rs. 8700/-.

- VII. The post carries usual allowances as admissible to Central Government Employees of similar status and other allowance sanctioned in AIIMS New Delhi.
- VIII. The qualification/eligibility prescribed is minimum requirement and the same does not automatically make candidates eligible for selection. Based on bio-data, the Selection Committee will short-list candidates who may be called for Interview. The candidates have to produce all relevant original documents as proof of details furnished in their application at the time of selection.
- IX. The applicants working in Central/State Govt./ need to be send their application through proper channel along with "No Objection Certificate" from their respective organizations. While forwarding the application, the following documents may be sent along with their application by the authority forwarding the application.
  - Complete ACR dossiers/ attested copies of ACRs of the applicant (last five years).
  - A certificate about the integrity of the Officer recommended for appointment on Deputation.
  - Vigilance clearance certificate in respect of the applicant duly signed by an authorized officer.
  - Major /minor penalty imposed if any, on the officer during last 10 years / service period whichever is less.

X. Interview may be conducted for selection to the post. It will be held at New Delhi. No TA/DA will be paid to candidates called for appearing in Interview by the Ministry of Health & Family Welfare.
