Sub: **Central Pool MBBS and BDS seats – Allocation for 2023-24 session- reg.**

The undersigned is directed to forward herewith a statement indicating the number of MBBS/BDS seats alongwith the Medical/Dental Colleges concerned, allocated for the academic session 2023-24 from the Central Pool for the Ministry of Education.

2. The admission of candidates to various medical colleges will depend on their fulfilling the eligibility criteria and other conditions of admission as laid down by the concerned State Govt. which may be ascertained from the concerned colleges.
3. The selection of eligible candidates will be made as per guidelines conveyed vide this Ministry's letter of even number dated 03rd August, 2023 (copy enclosed). The copy of the merit list together with copies of allotment letters may be sent to this Ministry. Any complaints/grievances with regard to selection of candidates may be redressed on a timely basis.
4. The selected candidates may be advised to report to the concerned college for admission well in time i.e. before the closing of admission and an intimation regarding their actual admission alongwith their full particulars including their marks, be sent to this Department within seven days of their admission.
5. It should be ensured that every selected candidate carries duly attested documents including his/her photographs when reporting for admission.
6. An intimation may be sent to the undersigned within 7 days of the actual admission of the selected candidates, alongwith full particulars and the category to which he/she belongs.
8. If any of the allocated seats is not utilized, the same may be surrendered to this Ministry before two weeks from the last date of admission, as notified by NMC/Dte.GHS.
9. In case, any seat remains unutilized and this Ministry is not informed forthwith, this Ministry may have no choice but to curtail the allotment of seats in the succeeding years.
