5. It should be ensured that every selected candidate carries <u>duly attested documents</u> including his/her photographs when reporting for admission.

6. If any of the allocated seats is not utilized, the same may be surrendered to this Ministry before two weeks from the last date of admission, as notified by NMC/Dte.GHS.

7. In case, any seat remain un-utilized and this Ministry is not informed forthwith, this Ministry may have no choice but to curtail the allotment of seats in the succeeding years.
