Further, it may also be intimated that in case the particular CPIO/Appellate Authority is on leave/tour, the deputed link officer will handle the disposal of the RTI cases and if the CPIO/Appellate Authority is transferred/retired, in that case the RTI work automatically will be assigned to the new incumbent in his/her place. The Section Officers at Sl.No.22 will act as CAPIO in the absence of the US & CPIOs for disposal of RTI cases. It is also intimated that Section Officers dealing with the subject matter under respective CPIOs will act as CAPIO in the absence of CPIOs for disposal of RTI related cases(As per earlier order of even number, dated 06.06.2014)
