**IV.** Those who are working in Central/State Govt/Union Territories, and their Autonomous Bodies only are eligible to apply and should send “No Objection Certificate” from their respective organization along with their application. While forwarding the application, the following documents may also please be sent along with the application.

- Complete ACR dossiers/attested copies of ACRs of the applicant (last five years).
- A certificate about the Integrity of the Officer recommended for appointment on Deputation.
- Vigilance Clearance in respect of applicant duly signed by an officer of the appropriate Status.
- Certificate, Major/Minor penalty imposed if any, on the officer during the last 10 years/service period whichever is less.

**V.** Applicants willing to join the Institutions on deputation only need to apply. The period of deputation shall ordinarily not exceed 3 years at a time. The pay will be protected as per Govt of India Rules.

**VI.** Upper age limit for applicants willing to come on deputation should not exceed 56 years as on 30<sup>th</sup> June 2014.

**VII.** The post carries usual allowances as admissible to Central Government Employees of similar status and other allowances sanctioned in AIIMS New Delhi.
