

## Call for Expression of Interest

### Register for Nomination- India CCM-Academic Institutions and Private Organizations (2022-2025)

Date of Issue: 14 July'2022

Last date of submission: 28<sup>th</sup> July, 2022

**Background:** The India Country Coordinating Mechanism (I-CCM) was established by the Ministry of Health and Family Welfare with the goal of strengthening measures to fight HIV/AIDS, TB and malaria in the country under GFATM funding support. It operates on a voluntary basis and is represents a multi-stakeholder partnership of governmental, nongovernmental, CSOs, communities, private sector, academia and development partners. The role of the India CCM is to ensure the proper coordination of the funds within the national response, provide national oversight and ownership of grant implementation. One of the core responsibilities of the India-CCM is to ensure compliance with the Global Fund eligibility requirements and minimum standards. **Objective:** The objective of this Expression of Interest (EoI) is to ensure equitable representation of private sector and academic institutions as well as Private Organizations, representing their constituencies to be part of the India CCM, for the term 2022 -2025.

**Process:** India-CCM members representing academic institution and private organization shall be nominated by that Organization. The selection process needs to be conducted in a transparent manner and documented in detail, by the organization. Members need to meet the eligibility criteria as detailed in the document.

The final selection of candidates needs to be endorsed by the institution and the organization. The entire process of identifying the nominee should be documented in detail by the institution and the organization and submitted along with application.

Once selected all representatives/organizations will be required to be an active member of India-CCM for a term of 3 years and participate in at least four meetings in a year.

Each institution and organization will also nominate an alternate to represent the institution/organization during the absence of the primary member. The alternate member will also be selected on the basis of the eligibility criteria as the primary member.

Applications may be submitted by 28<sup>th</sup> July, 2022 through email [iccmsect-mohfw@gov.in](mailto:iccmsect-mohfw@gov.in) indicating in the subject line the position they are applying for.

**Eligibility Criteria:**

All nominated members/alternates from academic institution and private organization should:

1. Not be a Principal or Sub Recipient of Global Fund grants or be working for any PR/SR with active grant in India
2. Have demonstrated experience of working in any one or on all the three areas of TB/HIV/Malaria in India for at least 5 years.
3. Be willing to sign a Conflict of Interest Declaration of India-CCM.

The final selection will be in accordance to approvals of Chairperson, India CCM.
