



G.S.R. No.....In exercise of the powers conferred by the proviso to article 309 of the Constitution and in suppression of the Recruitment Rules of Safdarjung Hospital, Dr. Ram Manohar Lohia Hospital, Lady Hardinge Medical College and Smt. Sucheta Kriplani Hospital, New Delhi in so far as they relate to the Group 'A' posts of Chief Nursing Officer, except as respects things done or omitted to be done before such suppression, the President hereby makes the following rules regulating the method of recruitment to the post of Chief Nursing Officer in the Safdarjung Hospital, Dr. Ram Manohar Lohia Hospital, Lady Hardinge Medical College and Srimiti Sucheta Kriplani Hospital in New Delhi, namely:-

1. Short title and commencement. – (1) These rules may be called the Ministry of Health and Family Welfare, Chief Nursing Officer, (Group 'A' Post), Recruitment Rules, 2024 of Safdarjung Hospital, Dr. Ram Manohar Lohia Hospital, Lady Hardinge Medical College and Shrimati Sucheta Kriplani Hospital in New Delhi,

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Number of post, classification and level in pay matrix. – The number of the said post, its classification and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.

3. Method of recruitment, age-limit, qualifications, etc. – The method of recruitment, age-limit, qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the said Schedule.

4. Disqualification. – No person, -

- (a) who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person,
- shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax.– Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving. – Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, the Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Deputation (Including Short-Term Contract):

Officers of the Central Government or State Government or Union Territories or Autonomous or Statutory Organization or Public Sector Undertakings or Universities or Recognised Research Institutions.

(i) Holding analogous posts on regular basis in the parent cadre or department, or

(ii) With five years regular service in post in the Pay Level -11 (Rs. 67700-208700) in the parent cadre of department Or

(iii) With ten years regular service in post in Pay Level- 10 (Rs. 56100-177500) in the parent cadre of department, and

Possessing the following minimum educational qualification from a recognized University or Institute:

Education Qualification

Essential : M.Sc. Nursing (from any speciality) / Nurse Practitioner (any specialty) from a recognised university or Institute.

Desirable – PhD Degree from a recognised university

Note 1: The departmental officers in the feeder category who are in direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for appointment by promotion.

Note 2: Period of deputation including short-term contract in another Ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Govt. shall ordinarily not to exceed four years.

Note 3: The maximum age limit for appointment by deputation including short term contract shall not exceeding fifty six years as on the closing date of receipt of applications.
