## NOTIFICATION

New Delhi, the....,2022.

G.S.R...- In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of "the Safdarjang Hospital and Willingdon Hospital and Nursing Home (Non-Medical Gazetted Posts) Recruitment Rules, 1977", in so far as it relates to the post of Administrative Officer, Willingdon Hospital and Safdarjang Hospital, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Administrative Officer in the Ministry of Health and Family Welfare, Dr. Ram Manohar Lohia Hospital, New Delhi, namely:-

1. Short title and commencement. - (1) These rules may be called the Ministry of Health and Family Welfare, Dr. Ram Manohar Lohia Hospital, New Delhi, Administrative Officer (Group 'B'

Post), Recruitment Rules, 2022.

- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of post, classification and level in the pay matrix. The number of the said post, its classification and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3. Method of recruitment, age-limit, qualifications, etc. The method of recruitment, age-limit, qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the said Schedule.
- 4. Disqualification. No person,
  - a. who has entered into or contracted a marriage with a person having a spouse living; or
  - b. who, having a spouse living, has entered into or contracted a marriage with any

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax. Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, and for reasons to be recorded in writing and in consultation with Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving. Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, the Ex-servicemen and other special categories of person in accordance with the orders issued by the Central Government from time to time in this regard.

Note 1 : Where Juniors who their completed have qualifying or eligibility service are being considered for seniors their promotion. would also be considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying years two or service whichever is less and have successfully completed their period probation promotion to the next higher grade along with their juniors who have already completed such qualifying or eligibility service.

Note 2: The departmental officers in the feeder category who are in direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for appointment by promotion.

Note 3: The period of deputation including period of deputation in another Excadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not exceed three years.

Note 4: The maximum agelimit for appointment by deputation shall be not exceeding fifty- six years as on the last date of receipt of applications.
