- G.S.R....- In exercise of the powers conferred by the proviso to article 309 of the Constitutio n and in supersession of the Safdarjang hospital, New Delhi central Sterilisation Room Assis tant, Technician (Sterilisation unit) and Senior Technician (Central Sterilise Service Departm ent) Group 'C' posts, Recruitment Rules, 2006, in so far as it relates to the post of Technicia n(Sterilization Unit), except as respects things done or omitted to be done before such super session, the President hereby makes the following rules regulating the method of recruitment to the post of Technician(Sterilization Unit) in the Ministry of Health and Family Welfare, Safd arjang hospital, New Delhi, namely:-
- 1. Short title and commencement. (1) These rules may be called the Ministry of Health and Family Welfare, Safdarjang hospital, New Delhi, Technician(Sterilization Unit), (Group 'C' Post), Recruitment Rules, 2023.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- Number of post, classifications and level in pay-matrix.— The number of the said post, its classification and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3. Method of recruitment, age-limit, qualifications, etc.—The method of recruitment, age-limit, qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the said Schedule.
- Disqualification. No person, -
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax. Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing and relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving. Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, the Ex-servicemen and other special categories of person in accordance with the orders issued by the Central Government from time to time in this regard.

Officers under the Central/State Government/Union Territ ories:-

- (a) (i)holding analogous posts on regular basis in the parent cadre/ department; or
- (ii)with 8 years regular service in post in Level-2 of the Pay Matrix (Rs. 19900-63200/-); and
- (b)possessing the following ed ucational qualifications and ex perience:
- (i)Class 12th Pass from a recognised Board; and (ii) At least one year Training in Sterilization techniques from a recognized Hospital or Medical Institute or

One year working experience in Central Sterilization Techniques from a minimum fifty bedded hospitals; or

Certificate or Diploma of at least nine months duration in Sterilisation Central Services from an Institute or Hospital recognised by the Central Government or State Union Government or Territory along with atleast 3 months working experience in Sterilisation Central Techniques from a minimum fifty-bedded hospitals.

Note 1: The Departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation/absorption. Similarly, Deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: Period of Deputation including period of Deputation in another ex-cadre post held immediately preceding this appointment in the same or

some other organization/ department of the Central Government shall ordinarily	
not to exceed three years. The maximum age limit for appointment by Deputation	
shall not be exceeding 56 years as on the closing date of receipt of applications).
