Monthly Cabinet Summary, June, 2024

Important policy decision taken and Major achievements during the month:

1. Progress of Flagship Programmes:

1.1 Against the revised target of 1.80 lakh operationalised Ayushman Arogya Mandirs (erstwhile Ayushman Bharat-Health & Wellness Centres), as reported by the States/UTs on the HWC Portal, **1,73,410** Ayushman Arogya Mandirs (AAM) have been operationalized till 30.06.2024 with more than 286.50 crore footfall recorded on these AAMs. As on 30.06.2024, 3.82 crore wellness sessions conducted including Yoga, 81.29 crore hypertension screenings, 71.48 crore diabetes screenings, 48.82 crore oral cancer screenings, 22.13 crore breast cancer screenings, 14.65 crore cervical cancer screenings and 25.19 crore teleconsultations have been conducted. In reporting month, 273 AAMs have been newly operationalized.

1.2 Under the National Sickle Cell Anaemia Elimination Mission, a total of **3,55,50,230** persons in 17 identified states has been screened and a total of 1,24,41,874 Sickle cell cards had been distributed till 30.06.2024. In reporting month, 32,01,265 persons have been screened for Sickle Cell Anemia.

1.3 Pradhan Mantri Janjati Adivasi Nyaya Maha Abhiyan (PM JANMAN) was launched on Janjatiya Gaurav Divas on 15th November 2023 by Hon'ble PM with an objective to improve the socio-economic conditions by saturating Particularly Vulnerable Tribal Groups (PVTG) families and habitations with basic facilities. Under PM JANMAN, **476 Mobile Medical Units (MMUs)** are operational against the target of 400 MMUs in PVTG areas of 16 States as of 30.06.2024.

2. Miscellaneous:

2.1 Pradhan Mantri Ayushman Bharat Health Infrastructure Mission (PM-ABHIM):

- Administrative approval accorded to the State of Gujarat amounting Rs. 570.11 Cr. and Rs.883.03 Cr. for FY 2024-25 & FY 2025-26 respectively on 13.06.2024.
- Launch of Guidelines for District Integrated Public Health Laboratory (DIPHL) in the august presence of Hon'ble Minister for Health & Family Welfare during event "Ayushman Bharat, Gunvatt Swasthya!" on 28.06.2024 in Vigyan Bhawan, New Delhi.

2.2 Under the Pradhan Mantri TB Mukh Bharat Abhiyaan, about ~1.60 lakhs Ni-kshay Mitras have come forward to adopt about **9.84 lakhs** consented TB patients (as of 02.07.2024).

2.3 Organized Natinal Launch of the STOP Diarrhoea Campaign 2024 on 24th June, 2024 under the leadership of Hon,ble Union Minister (HFW) along with Minister of States (HFW) in presence of Senior officials of MoHFW, State representatives from National Health Mission etc.

2.4 The Third Health Working Group meeting under the G20 Presidency Brazil was held in Salvador, Brazil during 2-6 June, 2024. The following plenary sessions in the 3rd Health working group meeting has been presented:

- Follow up Session: Global Innovation Hub and the Global Patient Safety Leaders Group (GPSLG) and Global Patient Safety Leaders Group (GPSLG) held on 3rd June, 2024.

- Climate Change and Health – Equity and One Health held on 5th June, 2024.
- Global Alliance for local and Regional Production and Innovation held on 6th June, 2024.
