

Subject: Implementation and Monitoring of Indradhanush Programme for vaccination – reg

- Vide the above referred letters, all the State Directors were requested to ensure action on the following points:-
 - Each of National Youth Volunteers (NYV) should motivate and immunize a minimum of 200 Children (0-5 yrs).
 - Members of the Youth Clubs be motivated to play a key role for vaccination of children and pregnant mothers under Indradhanush vaccination programme.
 - During conduct of NYKS programmes including Neighbourhood Youth Parliament, Skill Upgradation Training Programme etc, subject experts should be invited to deliver lectures and interact with the members of the Youth Clubs on different health issues including Indradhanush Programme for vaccination.
- You are aware that implementation of Indradhanush Programme for vaccination is the high priority area of the Central Government. Therefore, all the State Directors are requested to motivate the field functionaries to **achieve the set targets**.
- For this purpose, necessary **coordination with Chief Secretaries and Health Departments** of respective States be established. Maximum contribution should be made for **mobilisation of youth** for the effective implementation of this programme.
- State Directors are closely monitor the progress on regular intervals and to submit monthly as well as cumulative progress report in the prescribed proforma to NYKS Hqrs : mpsharmanyks@yahoo.co.in latest by **29th of every month**.
