Subject: Renewal of Permission for admission of 4th batch (150 seats) in MBBS Course at Malla Reddy College for Women, Hyderabad for the academic year 2016-17 u/s 10A of IMC Act, 1956.-Reg.

Sir/Madam,

As per Orders dated 19.09.2016 of the High Court of Andhra Pradesh and Telangana in WP No. 31621 of 2016, the Supreme Court Mandated Oversight Committee considered the application/representation of Malla Reddy College for Women, Hyderabad and approved the application of the college for admitting 4th Batch (150 seats) in MBBS Course at Malla Reddy College for Women, Hyderabad for the academic year 2016-17 u/s 10A of IMC Act, 1956 subject to submission of the following:

- i. An affidavit from the Dean/Principal and Chairman of the Trust concerned, affirming fulfilment of all deficiencies and statements made in the compliance report submitted by the College to MHFW (by 27th September, 2016).
- ii. A Bank Guarantee in the amount of Rs. 2 crore in favour of MCI, which will be valid for 1 year or until the first renewal assessment, whichever is later. Such Bank Guarantee will be in addition to the prescribed fee submitted alongwith the application (by 27th September, 2016)..

2. The OC has also stipulated as follows:-

- (a) OC may direct inspection to verify the compliance submitted by the College and considered by OC, any time after 30 September 2016.
- (b) In default of the conditions (i) and (ii) in para 1 above and if the compliances are found incomplete in the inspection to be conducted after 30 September 2016, such College will be debarred from fresh intake of students for 2 years commencing 2017-18.

3. Accordingly Renewal of Permission for admission of 4th batch (150 seats) in MBBS Course at Malla Reddy College for Women, Hyderabad for the academic year 2016-17 u/s 10A of IMC Act, 1956 is hereby issued subject to furnishing documents/ bank guarantee as per para 1 above in favour of Medical Council of India, New Delhi from a nationalized/Scheduled Bank by the stipulated date to this Ministry. In the event of non-submission of the affidavit and Bank Guarantee within the stipulated period, this Renewal Permission shall stand withdrawn.

4. This permission is valid for one year and for admitting only one batch of 150 MBBS students during the academic session 2016-17. The next Batch of students in MBBS course will be admitted in the College only after permission of the Central Government for renewal and fulfilling the condition of OC stipulated in para 2 of this letter.



5. Admissions made in violation of the above conditions will be treated as irregular and action under IMC Act, 1956 & Regulations made thereunder will be initiated.
7. Discrepancies, if any, may be brought to the notice of MCI and Central/State Government.
