ORDER

The President is pleased to grant Non-Functional Up-gradation to Supertime Administrative Grade **(SAG)** level to 22 (twenty two) officers of General Duty Medical Officer sub-cadre of the Central Health Service in the Pay Band 4 in the scale of Rs. 37400-67000 + Grade Pay Rs. 10000 (pre-revised) with effect from the date indicated against their names in Annexure, as per provisions of this Order and subject to procedural requirement as indicated in Para 5 hereunder.

- 2. The Non-Functional Up-gradation is being granted to the officers under Rule 13 of CCS (Revised) Pay Rules, 2008.
- 3. In case any officer remained unauthorisedly absent from duty during the last five years prior to the date of Non-Functional Up-gradation, he/she may not be granted Non-Functional Up-gradation till a decision regarding regularization of the period of unauthorized absence is taken. The details of such cases may be reported to this Ministry.
- 4. The up-gradation granted under these orders will be purely non-functional, personal to the officer and it would not bestow any right to the officer to claim promotion or deputation benefits based on Non Functional Up-gradation.
- 5. For implementation of these orders (including attendant benefits/pay-fixation, etc.), Units are requested to ensure that the officers are clear from vigilance angle, including the currency period of penalty, if any, as per instructions issued by the Department of Personnel & Training (DoPT) from time to time for the purpose of promotion/up-gradation. However, as per this Ministry's OM No. A.45011/37/2017-CHS.II(pt.) dated 17.09.2018 vigilance clearance may not be insisted upon for grant of benefits of NFU to SAG level in respect of retired officers of GDMO sub cadre of CHS who are drawing full pension after retirement.
- 6. A copy of this order may be made available to the officers concerned.
- 7. Discrepancies, if any, found may be brought to the notice of this Ministry within 30 days from the date of issue of this order.
