Subject: Seeking details of local manufacturers of medical devices/equipment for procurement by agencies under Govt. of India for the purpose of Public Procurement (Make in India) Order, 2017 - regarding

The Department for Promotion of Industry and Internal Trade (DPIIT) has issued the Public Procurement (Preference to Make in India) (PPP-MII) Order, 2017 dated 16.09.2020. In pursuance of the same, the Department of Pharmaceuticals had issued guidelines dated 16.02.2021 for implementation of the Order related to procurement of goods and services in Medical Devices. Both the orders can be accessed on the website of the Department at https://pharmaceuticals.gov.in/policy.

- 2. Various representations have been received from procuring agencies under the Government of India such as Central Medical Service Society, Employees State Insurance Corporation, All India Institute of Medical Sciences, New Delhi, Railway Board, Directorate General of Armed Forces Medical Services, HLL Infra Tech Services Ltd with regard to non-availability of Class-I or Class-II suppliers for identified Medical Devices/Equipment. An exercise was done to ascertain the local manufacturers from different sources for these identified Medical Devices/Equipment including the domestic manufacturers association.
- 3. However, recognizing that the manufacturers of the identified medical devices may be spread across the country and which may not be member of any manufacturers association and to give a reasonable opportunity, the list of said medical devices/equipment has been published and displayed on the website of Department of Pharmaceuticals in concurrence with DPIIT to collect the details of

local manufacturers vide Public Notice dtd 18.12.2021. The Public Notice can be accessed on the website of the Department at https://pharmaceuticals.gov.in/policy

- 4. DPIIT has also advised that such list of medical devices should be displayed on GeM Portal, CPP Portal, DPIIT and MoHFW websites. Accordingly, the **Public Notice dated 18.12.2021** issued by the Department is shared with a request to upload the same on the respective websites of the Ministries and the portals of the procuring agencies, under your department/ministry.
