

3. On promotion to the post of CMO (NFSG), the pay of the officers shall be fixed in the scale of pay of Rs. 37,400-67,000/- (pre-revised) in Pay Band-4 with grade pay of Rs. 8,700 plus NPA at the prescribed rates under CCS (RP) Rules, 2008 as amended from time to time.
