



NOTIFICATION

New Delhi, the, 2024.

GSR..... In exercise of the power conferred by the proviso to Article 309 of the Constitution and in supersession of the "Govt. Medical Store Depots (Class III and IV Posts) Recruitment Rules 1983" and amendment dated 28.04.1994, in so far as they relate to the posts (viz. Assembler-cum-Checker, Checker, Packer, Daftry, Record Keeper, Record Supplier, Chowkidar, Markman, Mazdoor, Peon, Safaiwala, Factory Hand, Hamalage Coolie, Hamallage Mukadam, Mali, Gestener Operator, Lab Attendant, Laboratory Hand, Bearer, Tea-Maker, Cleaner, Lorryman, Boiler Cleaner, etc.) which are re-designated as MTS except as respects things done or omitted to be done before the supersession, the President hereby, makes the following rules regulating the method of Recruitment to the post of Multi-Tasking Staff in the Govt. Medical Store Depots under Medical Stores Organization, Directorate General of Health Services, Ministry of Health & Family Welfare namely.

1. Short title and commencement. - (1) These rules may be called the Ministry of Health and Family Welfare, Government Medical Store Depots, Multi-Tasking Staff (Group 'C') Recruitment Rules, 2023.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Number of post, classification and level in pay matrix. - The number of the said post, its classification and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.

3. Method of recruitment, age-limit, qualifications, etc. - The method of recruitment, age-limit, qualifications and other matters relating to the said post shall be as specified in columns (5) to (14) of the said Schedule.

4. Disqualification. - No person,

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax. - Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing and relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving. -Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Other Backward Classes, the Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
