G.S.R.....—In exercise of the powers conferred by the proviso to article 309 of the Constitution, and in supersession of, ----

(i) the Willingdon Hospital and Nursing Home (Class III posts) Recruitment Rules, 1973, in so far as they relate to the post of Laboratory Assistant; and Museum Curator; and

(ii) Dr. Ram Manohar Lohia Hospital, New Delhi Technical Supervisor (Laboratories) and Senior Technical Assistant (Laboratories) Recruitment Rules, 1996; and

except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the posts of Medical Laboratory Technologist, Technical Officer (Medical Laboratory Technologist), Senior Technical Officer (Medical Laboratory Technologist) and Chief Technical Officer (Medical Laboratory Technologist) in Ministry of Health and Family Welfare, Dr. Ram Manohar Lohia Hospital, New Delhi, 2019, namely:-

1. Short title and commencement. – (1) These rules may be called the Medical Laboratory Technologist, Dr. Ram Manohar Lohia Hospital, New Delhi, Recruitment Rules, 2019.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Application. – These rules shall apply to the posts specified in Column(1) of the Schedule annexed to these rules.

3. Number of posts, classification, and level in the pay matrix. – The number of the said posts, their classification and level in the pay matrix or pay scale attached thereto shall be as specified in columns (2) to (4) of the said Schedule.

4. Method of recruitment, age-limit, qualifications, etc. – The method of recruitment, age-limit, qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the said Schedule.

5. Disqualification. – No person, -

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said posts:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

6. Power to relax. – Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, and in consultation with the Union Public Service Commission and reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

7. Saving. – Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-servicemen, other Backward Classes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

(b) possessing the following qualifications and experience

Bachelors degree in Medical Laboratory Science from a Government recognized university or Institute and two years' experience as Medical Laboratory Technologist or Laboratory Technologist from any recognized Hospital or Institute

Note 1: The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, the deputationist shall not be eligible for consideration for appointment by promotion.

Note 2: The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central government shall ordinarily not exceed three years.

The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the last date of receipt of applications.
