Notification

G.S.R....:-In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Safdarjang Hospital, New Delhi ,Chief Sanitary Superintendent, (Group 'C') Recruitment Rules 1996, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Chief Sanitary Superintendent in the Ministry of Health and Family Welfare, Safdarjang Hospital, New Delhi, namely:-

- 1. Short title and commencement. (1) These rules may be called the Ministry of Health and Family Welfare, Safdarjang Hospital, New Delhi, Chief Sanitary Superintendent Recruitment Rules, 2019.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of post, classification, level in the pay matrix. The number of the said post, its classification and level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3. Method of recruitment, age limit, qualifications, etc. The method of recruitment agelimit, qualification and other matters relating to the said post shall be as specified in columns (5) to (13) of the said Schedule.
- 4. Disqualification. No person, -
 - (a) who has entered into or contracted a marriage with a person having a spouse living, or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax. Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving .- Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, Ex-servicemen and other special categories of person, in accordance with the orders issued by the Central Government from time to time in this regard.

- (I) Officers under the Central Government or State Government or Union territory Administration or autonomous or statutory organisations or Public Sector Undertakings or University or recognised research institutions:
- (a) (i) holding analogous posts on regular basis in the parent cadre/department; or
- (ii) with six years service in grade rendered after appointment thereto on regular basis in level 5 in the pay matrix (29200-92300) in the parent cadre/department;

and

- (b) possessing the following educational qualification:
 - (a)(i) Bachelor degree in any discipline from any recognised university/institute.
 - (ii) Diploma in Sanitary Inspector course or diploma in Health Inspector course or diploma in Sanitary Health Inspector course.

or

(b)(i) 12th class pass from a recognized board.

(ii)diploma in sanitary inspectors course or diploma in Health's Inspector's course or Diploma in

Sanitary Health Inspector;

(iii) two years experience in dealing with sanitation works in any recognised organization.

Note 1: the departmental officers in the feeder category who are in direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: Period of deputation including period of deputation in another excadre post held immediately preceding this appointment in the same or some other organization/ department of the Central Government shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications.
