ORDER

Subject: **Sridev Sumban Subharti Medical College & Hospital, Dehradun**Confirmation of conditional permission and permission to admit students (150 seats) in MBBS Course for the year 2017-18.

Whereas in compliance of direction dated 01.08.2017 of Hon'ble Supreme Court in W.P (C) No. 513 of 2017, the Ministry granted a hearing to **Sridev Sumban Subharti Medical College & Hospital, Dehradun** and reiterated its earlier decision to debar **Sridev Sumban Subharti Medical College & Hospital, Dehradun** from admitting students in MBBS Course (150 seats) for two years i.e. 2017-18 & 2018-19 vide its order dated 14.08.2017;

2. Whereas the Hon'ble Supreme Court in Writ Petition (C) No.513/2017 with I.A. No.74980/2017 vide order dated 31.08.2017 directed as under:-

Considering the fact that the admission process for the academic session 2017-18 is still in progress and the last date fixed for counseling is 31st August, 2017, we are inclined to issue directions to all concerned to permit the petitioner-college to admit up to 150 students until 05.09.2017 to the MBBS course for the academic session 2017-18, with liberty to MCI and the competent authority to inspect the petitioner-college and if any deficiency is noticed, 1 2017 (8) SCALE 369 to proceed against the petitionercollege in accordance with law. Accordingly, we allow these writ petitions and interlocutory applications. The impugned decision of the competent authority of the Central Government dated 14th August, 2017, is quashed and set aside. Further, respondents are directed to permit the petitioner-college to admit up to 150 students until 05.09.2017 for the academic session 2017-18 and allot students through the central counselling in order of their merit for the academic session 2017-18 in the MBBS course.



- Now, therefore, in compliance of the above order of the Hon'ble Supreme Court the Ministry hereby confirms the conditional permission granted to Sridev Sumban Subharti Medical College & Hospital, Dehradun in 2016-17 and permits the College to admit students (150 seats) in MBBS course for the academic year 2017-18;
- The Next batch of students in 2018-19 with 150 seats will be admitted only after 4. obtaining permission from the Central Government;
- Admissions made in violation of above conditions will be treated as irregular and 5. action will be taken as per provisions of IMC Act, 1956 and the Regulations made there under:
- MCI and the competent authority are at liberty to inspect the College and to proceed 6. against the College if any deficiency is noticed;
