Ten year's experience in the profession after acquiring postgraduate qualification, out of which four year's should be as Reader/Associate Professor in a Recognized Medical College/Teaching Institution.

#### Desirable:

Minimum four research publications indexed in Index Medicus/National Journals and one Research Publication in International Journals.

The Departmental Officer in the grade of Reader (ENT) with two years regular service in the grade will also be considered alongwith outsiders and in case he she is selected for appointment to the post, the same shall be deemed to have been filled by promotion.

The Departmental Officer in the feeder category who are in direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Period of deputation/contract including period of deputation/contract in another ex-cadre post held immediately preceding this appointment in the same or some other organization/ department of the Central Government, shall ordinarily not exceed five years. The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding 56 year's as on the closing date of receipt of applications.

For appointment by Deputation (including Short-term Contract) not exceeding 56 years as AGE LIMIT: on the closing date of receipt of applications.

Statement of major/ minor penalties, if any, imposed on the candidate during the last 10 (V) years or a no penalty Certificate, as the case may be.
